SUMMARY RECORD

FIRST MEETING OF THE INTER-MINISTERIAL WORKING GROUP ON GREEN GROWTH INDICATORS

12 December 2016 Baku, Azerbaijan













- 1. A workshop on "Green Growth Measurement in Azerbaijan" in Azerbaijan was organised on 19 May 2016 to discuss the current progress in greening the economy and the relevance of establishing a green growth measurement framework in Azerbaijan, as part of the European Union regional project "Greening Economies in the Eastern Neighbourhood" (EaP GREEN). The participants, including representatives from the Ministry of Economy and Industry, Ministry of Ecology and Natural Resources and the State Statistical Committee, agreed to proceed with the creation of an Inter-Ministerial Working Group on Green Growth Indicators to further define and implement green growth indicators in the country.
- 2. The mandate of the Inter-Ministerial Working Group on Green Growth Indicators (WGGGI), chaired by the Ministry of Economy, is to identify and develop green growth indicators that can be used to assess progress towards green growth of the Azerbaijan's economy. It is anticipated that the public authorities, the expert community and civil society organisations working on green growth issues and, ultimately, all citizens of Azerbaijan will be the main beneficiaries of the efforts of the Working Group on GGIs.
- 3. The main purposes of the WGGGI will be to guide, oversee and agree on the set of green growth indicators (GGIs) based on existing data and identify those indicators for which data flows should be established; oversee the preparation of a GGI-based report that will show progress and trends towards greening the economy of Azerbaijan; and disseminate and communicate project results to key stakeholders in Azerbaijan, to ensure the regular revision, update and use of green growth indicators.
- 4. This first meeting of the Working Group gathered stakeholders to discuss the choice of green growth indicators and the development of a report on green growth in Azerbaijan. Participants of the first meeting of the WGGGI included representatives of the Ministry of Economy, Ministry of Ecology and Natural Resources, State Statistical Committee, State Agency on Alternative and Renewable Energy Sources. Mr. Orkhan Kazimov and Mr. Robert Smith were hired by the Organisation for Economic Cooperation and Development (OECD, represented at the meeting by Ms Mikaela Rambali) as part of the EaP GREEN project to prepare the indicators-based report in Azerbaijan (see the full list of participants in Annex 1).

Agenda Item 1. Opening remarks

5. The participants took note of welcoming remarks by Mr. Murad Abdullayev (Ministry of Economy). He underlined the importance of integrating the green economy concept in strategic policy documents, especially as part of the 2020 Future Vision of Azerbaijan and the recently adopted Economic Reform Road Map that promote economic and energy diversification.

Agenda Item 2. Introduction to the OECD green growth measurement framework

6. Under this agenda item the participants took note of the presentation by Ms Mikaela Rambali (OECD) on the OECD green growth strategy, its green growth measurement framework. She then gave examples of its application in OECD member and non-member countries, including on challenges and lessons learned in terms of indicator selection, data compilation, interpretation and institutional coordination.

Agenda Item 3. Statistical indicators system on the "green economy"

7. Under this agenda item the participants took note of the intervention by Ms. Rena Lazimova, State Statistical Committee of Azerbaijan, on the Committee's work on environmental and economic information. She mentions the 2013 State Programme for Statistical Development including work on green economy and databases.

Agenda Items 4-6. Discussion on each of the group of green growth indicators

- 8. In this part of the meeting, Mr. Orkhan Kazimov presented the indicators that were chosen for representing the greening of the economy of Azerbaijan, as part of the list prepared by the State Statistical Committee. Ms. Mikaela Rambali followed by providing examples of what other countries had chosen for their own list of green growth indicators. The participants discussed the relevance of the proposed indicators for showing progress with greening the economy. Other indicators were suggested and considered to be added to the list of indicators.
- 9. The discussion was structured around the four groups of indicators suggested by the OECD:
 - 1. the indicators on environmental and resource productivity of the economy
 - 2. the indicators on the natural asset base
 - 3. the indicators on environmental dimension of quality of life
 - 4. the indicators on the economic opportunities and policy responses

Agenda Items 7-8. Finalisation of the GGI list and preparation of the GGI report

- 10. The members of the WGGGIs:
 - considered how to best integrate green growth measurement in the governmental agenda;
 - Agreed to join forces to contribute to a government report on Green Growth Indicators in Azerbaijan that would present the state and trends of greening the economy of Azerbaijan using the approved list of GGIs;
 - Agreed that the report would be published under the authority of the Ministry of Economy;
 - And expressed interest in having a next meeting of the WGGGI (March 2017 tbc).
- 11. As agreed during the May workshop, the preparation of the report on GGI is being undertaken by Mr. Orkhan Kazimov a national consultant, in collaboration with local experts and relevant stakeholders/members of the Working Group and helped by an international expert, Mr. Robert Smith. The OECD provided funding for hiring consultants through the EaP GREEN project.
